Dear Parents/ Carers,

Your child has been offered a place in the quality music program at Theodore Primary. The students will be learning ukulele. This is an **OPTIONAL** program.

Claire Leske is the Instrumental Music Program teacher and will be taking the ukulele band each week. The band sessions take place on Tuesday and Thursday afternoons during school hours.

The whole cost of taking part in the program for the **two** years is \$200. **This cost includes a brand-new ukulele for the students to keep, music folders and the weekly lessons.** This is a **once off** payment and will cover the **two** years of the program.

Being a member of the Ukulele band **requires a two-year commitment.** Please have a conversation with your child about what this may mean.

The band payment of \$200.00 will be payable by Friday 19 March 2021 (end of Week 7 Term 1).

Until we have received a \$100 deposit or higher, the students will leave their ukuleles at school.

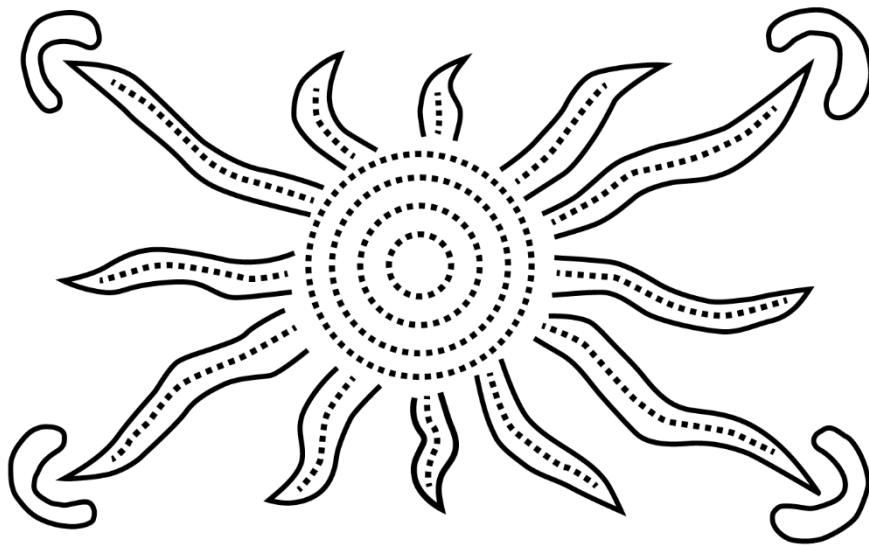
Act Education Privacy Information
