Information for Year 5/6 Borambola Camp 2021

Dear Parents and Caregivers,

We are very excited about the upcoming Year 5/6 camp at Borambola Sport & Recreation, which will take place from Monday 15th to Wednesday 17th March 2021.

Borambola is an educational Sport and Recreation camp, managed by qualified instructors, which is situated approximately 30km east of Wagga Wagga.

Students will stay in cabins and the camp has shared bathroom facilities. Staff accommodation is in close proximity to these rooms to provide after-hours supervision.

Travel to and from Borambola will be provided by Murrays Coaches. Students attending the camp need to be at school on the Monday at **7.00am for a 7.30am departure**. Camping students and staff will arrive at Borambola at approximately 11.30am. Departure will be at approximately 1.30pm on Wednesday 17th March and we should arrive at Theodore Primary School at approximately 5.30pm. The school Facebook page and Front Office will be able to advise on the day of exact arrival times.

**Please note the children are required to bring morning tea for Day One. **

Activity Instructors – Accredited Borambola staff will run each activity (20 students maximum per group plus a Theodore staff member).

Medicines – If your child is required to take prescribed medicine to camp please contact the front office to collect required forms. Please arrange approx. two weeks prior camp departure to ensure all requirements are met. All medicines accompanying your child will need to be in a zip-lock bag clearly labelled with the medical forms attached noting the correct dosage and time to be administered. Medicines will be the responsibility of Jess Crilly. Medicines will need to be given to Ms Crilly day prior to departure.

Attending Staff – Executive teacher, Year 5/6 teachers

Please note: staff accompanying students on excursions will take all reasonable care while the children are in their charge to protect them from injury and to control and supervise their behaviour and activities. Parents should be aware that staff members are not responsible for injuries or damage to property which may occur on an excursion where, in all circumstances, staff have not been negligent. Please talk with your child about the importance of being a safe, respectful, learner while at camp as outlined in the camper's agreement.


Act Education Privacy Information
